CONDITIONS

This notice is given on the condition that:


- (A) Royal Bank of Scotland plc (RBS) plc ensures that it maintains financial resources which are adequate in relation to the nature, size and complexity of its business to ensure that there is no significant risk that liabilities cannot be met as they fall due; and
- (B) RBS plc, on a quarterly basis, submits to the QFC Regulatory Authority a copy of its Financial Services Authority (FSA), UK financial reporting statement within 10 business days after it is due to be submitted to the FSA UK.

INTERPRETATION

The provisions in this notice are to be construed as if these provisions are provisions of the Rulebooks.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Interpretation and Application Rulebook (INAP). Unless the context otherwise requires, where capitalisation of the initial letter is not used, an expression has its natural meaning.
