This notice is given on the condition that:


- (A) during the term of this notice the above mentioned Person submits to the QFC Regulatory Authority on a monthly basis a report outlining progress made towards a permanent appointment for the Money Laundering Reporting Function; and
- (B) during the term of this notice the Approved Individual carrying out the Money Laundering Reporting Function is Mr Aravindhakshan Konjadath Valappil and that he remains ordinarily resident in the State of Kuwait.

## INTERPRETATION

The provisions in this notice are to be construed as if these provisions are provisions of the Rulebooks.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Interpretation and Application Rulebook (INAP).
