**Effective Date:** This notice comes into effect on 4 April 2007 and remains in effect until 31 December 2007.

## **CONDITIONS**

This notice is given on the condition that:

- (A) The Royal Bank of Scotland plc ensures that it maintains financial resources which are adequate in relation to the nature, size and complexity of its business to ensure that there is no significant risk that liabilities cannot be met as they fall due; and
- (B) on a quarterly basis, The Royal Bank of Scotland plc submits to the QFC Regulatory Authority a copy of the latest UK Financial Services Authority (FSA) financial reporting statement within 10 business days after the date this is due to be submitted to the FSA.

## **INTERPRETATION**

The provisions in this notice are to be construed as if these provisions are provisions of the Rulebooks.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Interpretation and Application Rulebook (INAP). Unless the context otherwise requires, where capitalisation of the initial letter is not used, an expression has its natural meaning.
